### Directions to Verona from Bowling Green

From Bowling Green get onto 12/14 east (the beltline highway), take the Mineral Point road exit and turn right for about 1/8 mile, take a left on Hwy M and follow that approx. 5 miles to Verona, at the main intersection/stoplight in downtown Verona turn left onto Verona Avenue and go east 4 blocks to the next stop light, turn right at the light and that is actually the entrance to the park. As you drive into the lot you'll see the park shelter building which is the concession stand and overlooks the two softball fields. The actual street address of the park is 105 Lincoln St. but the old entrance off of Lincoln st was closed off this spring.
